

# NEW CRAFT SELLERS INFORMATION SHEET



The Davis Farmers Market welcomes new craft persons to our Wednesday and Saturday markets. The market is located at Central Park in downtown Davis. Our market hours are:

<b>Saturdays</b>	<b>8 a.m.-1 p.m.</b>	<b>**Year Round**</b>
<b>Wednesdays</b>	<b>2-6 p.m.</b>	<b>(Nov – mid-Mar)</b>
<b>Wednesdays</b>	<b>4:30-8:30 p.m.</b>	<b>(mid-Mar - Oct)</b>

To be considered to sell crafts at the Davis Farmers Market you must do the following:

- 1) Contact the Davis Farmers Market office before submitting a craft application. The phone number is (530) 756-1695 or you can email [dfma@dcn.org](mailto:dfma@dcn.org).
- 2) Submit a Davis Farmers Market application to sell (available on our website—<http://www.davisfarmersmarket.org/>) to the Market at P.O. Box 1813, Davis, CA 95617. Please include a representative sample of your work in its finished form and a \$25 craft review fee.
- 3) Please be aware that all crafts sold at the Davis Farmers Market **must be thematic with the Farmers Market**. Crafts must reflect images of agriculture, agrarian lifestyle or the Market in general and also demonstrate fine craftsmanship. Craft must be created truly from scratch. **The component materials must be sufficiently modified from their original state to demonstrate fine craftsmanship.**
- 4) Once your application and samples are submitted, they will then be reviewed by the Craft Review Committee (which meets three times a year or as necessary) for approval. The Market office will contact you within two business days of the craft review to notify you of the decision. **Only** those items approved at the review may be sold at the market.
- 5) After your application is approved and all necessary documents are received, the Market office will provide you with a Quarterly Crafter Sign Up Sheet. You must provide the dates you will attend, as soon as possible, as space is limited.
- 6) The current fee structure for selling at the Market is:

**Members:** 6% of gross sales (\$30.00 minimum on Saturday, \$20 minimum at Picnic in the Park.)

**Non-Members:** 8% of gross sales, \$26.00 minimum (You must be a member to sell on Saturday.)
