## NEW CRAFT SELLERS INFORMATION SHEET

The Davis Farmers Market welcomes new craft persons to our Wednesday and Saturday markets. The market is located at Central Park in downtown Davis. Our market hours are:

<b>Saturdays</b>	<b>8 am until 1 pm</b>	<b>*****Year Round*****</b>
<b>Wednesdays</b>	<b>3 pm until 6 pm</b>	<b>*****Oct-Apr*****</b>
<b>Wednesdays</b>	<b>4 pm until 8 pm</b>	<b>*****May-Sep*****</b>

To be considered to sell crafts at the Davis Farmers Market, please:

- Email the Davis Farmers Market office before submitting a craft application ([dfma@dcn.org](mailto:dfma@dcn.org)). Please include digital photos of the products you wish to sell and your contact information. We will contact you and send you an application to sell, which you can then submit to us along with a representative sample of your work in its finished form along with a \$25 craft review fee.
- Be aware that all crafts sold at the Davis Farmers Market **must be thematic with the Farmers Market**. Crafts must reflect images of agriculture, agrarian lifestyle or the Market in general and also demonstrate fine craftsmanship. Craft must be created truly from scratch. **The component materials must be sufficiently modified from their original state to demonstrate fine craftsmanship.**
- Once your application and samples are submitted, it will be forwarded to the Craft Review Committee, which meets quarterly. The Committee will approve or deny the submission. The Market office will contact you after the reviews are completed to notify you of the decision. The decision of the Craft Review Committee is final and cannot be appealed. **Only** those items approved at the review may be sold at the market.
- Note that, if your application is approved and all necessary documents are received, the Market office will include you on the email for Quarterly Crafter Sign Ups. You must provide the dates you will attend, as soon as possible, as space is limited. Cancellations must be emailed by the Thursday at 5pm prior to your Saturday reservation day. You may also phone the office with your cancellation (530-756-1695). Late cancellations will be subject to a \$15 fee.

NEW SELLERS: The \$40 Registration Fee will be added to your Seller Load Sheet on your first selling day at Market.

The current fee structure for selling at the Market is:

**Registered Sellers:** 7% of gross sales (\$30 minimum on Saturday, \$20 minimum on Wednesday.)

**Non-Registered Sellers** (Wednesday, Central Park & Thursday, Sutter Davis Hospital-ONLY): 8% of gross sales, \$34 minimum. You must be a registered seller to sell on Saturday.

Your \$40 New Seller Registration Fee will be included in your Load Sheet on the first day you sell.

NOTE: The decision of the Design Review Team is final and cannot be appealed.
